

**HANG OUT WITH LINKIN PARK & WIN GREAT TICKETS TO THEIR SHOW
A PROMOTION TO BENEFIT MUSIC FOR RELIEF
OFFICIAL RULES**

NO PURCHASE, DONATION OR FUNDRAISING OF ANY KIND IS REQUIRED TO ENTER OR WIN. A PURCHASE, DONATION OR FUNDRAISING WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

THESE OFFICIAL RULES CONTAIN AN ARBITRATION AGREEMENT, WHICH WILL, WITH LIMITED EXCEPTION, REQUIRE YOU TO SUBMIT CLAIMS YOU HAVE AGAINST SPONSOR AND/OR CROWDRISE (EACH, AS DEFINED BELOW) TO BINDING AND FINAL ARBITRATION. UNDER THE ARBITRATION AGREEMENT, (1) YOU WILL ONLY BE PERMITTED TO PURSUE CLAIMS AGAINST SPONSOR OR CROWDRISE ON AN INDIVIDUAL BASIS, NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY CLASS OR REPRESENTATIVE ACTION OR PROCEEDING, AND (2) YOU WILL ONLY BE PERMITTED TO SEEK RELIEF (INCLUDING MONETARY, INJUNCTIVE, AND DECLARATORY RELIEF) ON AN INDIVIDUAL BASIS.

Donations made in the Promotion (as defined below) go to Music for Relief, EIN 20-2142644, a non-profit organization qualified under Section 501(c)(3) of the U.S. Internal Revenue Code of 1986, as amended. 1. INTRODUCTION: Linkin Park’s Promotion (hereinafter, the “Promotion”) is a series of sweepstakes sponsored by GoFundMe, Inc. (“Sponsor”) and administered by CrowdRise, Inc. (“CrowdRise” and “Administrator”). Live Nation and Music for Relief (each a “Prize Provider”) are responsible for providing the prize(s) for the Promotion. Live Nation will be providing the tickets and Music for Relief will be providing the Meet & Greet. Music for Relief is the benefitting charity (“Benefitting Charity”). Your participation in the Promotion means that you unconditionally agree to these Official Rules and all decisions by Sponsor, Administrator, Prize Provider and Benefitting Charity which are final and binding in all matters related to the Promotion. To win the prize(s), you must comply with all facets of the Official Rules and all decisions by Sponsor, CrowdRise, Prize Provider and Benefitting Charity.

2. ELIGIBILITY: The Promotion is open only to eligible individual legal residents of the 50 United States or the District of Columbia and Canada (excluding Quebec) (the “Eligibility Area”) who are age 13 or older or, if older, the age of majority in their jurisdiction at the time of entry who agree to and comply with these Official Rules. All entries made in connection with the Promotion are governed by these Official Rules. Employees of Sponsor, CrowdRise, Prize Providers, and their respective parents, affiliate companies, subsidiaries, agents, judges, advertising and promotion agencies and anyone involved in the development or execution of the Promotion, as well as the immediate family (spouse, parents, siblings, and children and their respective spouses, regardless of where they live) and household members of each such employee, whether or not related, are not eligible. All federal, state, provincial, municipal, territorial and local rules and regulations apply. Void where prohibited by law. The CrowdRise Terms and Conditions (<https://www.crowdrise.com/about/terms>) apply. In the event of a conflict between these Official Rules and the CrowdRise Terms and Conditions, these Official Rules govern and control only to the extent of such conflict.

By entering, each entrant understands and agrees that, if selected in the random drawing to be the Potential Winner (as defined in Section 6 below), he/she and his/her guest will be required to consent to a background check and/or screening to verify the winner’s and his/her guest’s identity and ensure the winner’s and guest’s compliance with the law and safety of others, in sole discretion of the Prize Provider and any other requirements to claim the prize; and, failure to sign such consents and authorizations and/or to furnish all required information will result in disqualification. In addition, Sponsor, Administrator and Prize Provider reserve the right in their respective, sole discretion, to disqualify the Entrant, Potential Winner if the results of such background check reveal that they are not eligible to participate in the Sweepstakes or claim the prize,

presents a safety risk or has been convicted of a felony or a crime of moral turpitude, as determined by Sponsor and Prize Provider in their sole discretion. The winner’s guest may be denied from accompanying the winner and winner may choose a new guest, time permitting and at the sole discretion of Prize Provider.

3. PROMOTION PERIOD AND DONATIONS: The Promotion begins on May 8, 2017 at 2:00:00pm Eastern Time (ET) and ends on August 8, 2017 at 11:59:59am ET (the “Promotion Period”) and consists of individual sweepstakes, one for each of the concert dates on Linkin Park’s Tour that is listed in the Table below. Each Sweepstakes is separate, with its own start/end date and time (“Entry Period”), drawing, prizes, and other details outlined in the Schedule below. CrowdRise’s server and computer clock is the official time-keeping device. If you enter via the free method described in Section 4(b) below, such entries must be received by CrowdRise before the end of the Promotion Period. If you enter by donating as described in Section 4(a) below, such donations must be successfully processed to completion through CrowdRise and its third party payment processor(s) **before** the end of the Promotion Period. CrowdRise has the right to verify any such donation, and any such donation that is subject to chargeback or dispute is not eligible. **Donations can take time to process.** Neither Sponsor nor CrowdRise is responsible for any delays in processing any donations. The list of donations on any particular fundraising page, if any is displaying or any similar tally of donation(s), are unofficial tallies of the amounts of donations in a campaign and may not accurately reflect the donations made based on a variety of factors. Results of the Promotion are not official until CrowdRise or a duly authorized representative expressly announces the final results and verifies the winner(s).

* Pick up your prize at will call at the venue unless otherwise instructed by Prize Provider/Administrator. Seat location is assigned by Prize Provider. Some venues do not have premium seating and seating is dependent upon the venue and varies at each. NOT ALL PRIZES ARE AVAILABLE FOR EVERY SHOW OF THE TOUR.

4. HOW TO ENTER AND WIN: Go to the CrowdRise website located at : <https://www.crowdrise.com/LinkinParkTour> (the "Website"). During the Entry Period, you may enter up to fifty (50) times total per person, per Sweepstakes by either of the following methods of entry or a combination of both methods:

- (a) **Method One: To Enter by Donation:** Donate at least ten dollars (\$10) on the Website for one entry. Every additional ten dollars (\$10) is an additional one (1) entry. To determine the number of entries in connection with each donation, your donation is broken down into dollar increments, with every ten dollar increment (\$10) constituting one (1) entry. Donations or dollars raised do not need to be exact or multiples of the increments listed above. Donations must be made on the Website using a credit card and successfully processed to completion (and not subject to any chargebacks or disputes) through CrowdRise and its third party payment processor during the Promotion Period to count toward the Promotion. Donations made outside of the Promotion Period and/or offline, even if recorded on the Website are not eligible and will not be counted. Assurance of delivery and

processing of donations is the sole responsibility of the entrant. Donations are non-refundable. Please note that although you may receive entries for the full amount of your eligible donation in accordance with the terms in these Official Rules, the ultimate recipient of your donation may receive less than the full amount that you donate after the deduction of administrative and processing fees in accordance with the CrowdRise Terms and Conditions.

- (b) **Method Two: To Enter for Free:** Go to: <https://www.crowdrise.com/FreeAlternateMethodofEntry> and follow the on-screen instructions to submit a “Free Alternate Method of Entry” form by entering your name, mailing address, birthdate, email and the name of the Promotion (Linkin Park Tour 2017 Promotion) and name of the Sweepstakes (City, State). Your form must be submitted and received during the Promotion Period and must be complete and accurate, or your entry is automatically void.

Regardless of method of entry, all entries are subject to verification of eligibility before a prize can be awarded. For example, if your birthdate or address entered on the Website or otherwise during the entry process does not meet eligibility requirements, your entry is automatically void. Your receipt and any confirmation email you receive are not confirmation of entry.

Charitable tax receipts will not be issued to all donors/entrants. Donations made by entrants and winner(s) may not be tax-deductible and the winner(s)'s prize may be taxable. It is the individual entrant's sole responsibility to determine the tax-consequences of their donations. Every Participant agrees that information provided by Sponsor is not advice, including but not limited to, tax advice or legal advice, and every participant is advised to consult a professional, including a tax professional.

Those who do not provide the required information in their donation or entry form, or abide by these Official Rules or other instructions of Sponsor, CrowdRise or Prize Provider may be disqualified at Sponsor's, CrowdRise's or Prize Provider's sole and absolute discretion. All entries that are late, illegible, incomplete, damaged, destroyed, forged or otherwise not in compliance with the Official Rules may be disqualified from the Promotion at Sponsor's, CrowdRise's or Prize Provider's sole and absolute discretion.

In the event of a dispute as to the identity of any entrant, the entry will be deemed submitted by the account holder of the email from which it was sent but only if such person is otherwise eligible. The “account holder” is the person assigned an email address or username by the entity responsible for assigning it (e.g., Gmail). Potential Winner(s) may be required to show proof of being the registered account holder. If a dispute cannot be resolved to the Sponsor's, CrowdRise's and Prize Provider's satisfaction, the entry will be deemed ineligible.

Your participation in the Promotion is voluntary and does not require you to purchase anything from the Sponsor, CrowdRise or Prize Provider.

There is a limit of fifty (50) entries total permitted per person, per Sweepstakes, regardless of method of entry, during the Promotion Period.

5. PRIZES: There will be five (5) winners per sweepstakes. The winners will receive the following:

There will be four (4) winners per sweepstakes (city/state listed in the Schedule in Section 3), each who will receive two (2) tickets for winner and his/her guest to see Linkin Park in concert.

There will be one (1) winner per sweepstakes who will receive two (2) tickets for winner and his/her guest to see Linkin Park in concert two (2) meet & greet passes for winner and his/her guest to meet member(s) of Linkin Park.

Restrictions Apply:

Potential winner is not declared final and shall not receive a Prize until winner (and guest) are each verified by Prize Provider or its representative per Section 6 below.

The Approximate Retail Value (“ARV”): three hundred dollars (\$300 USD) for two (2) tickets and three hundred dollars (\$300 USD) for two (2) Meet & Greet passes. The ARV of the prize represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prize turns out to be less than the stated ARV, the difference will not be awarded in cash.

Winner's tickets are for winner and his/her one (1) guest and may not be transferred, sold, exchanged, auctioned or returned. Seat location is assigned by Prize Provider. Exact seat location is not revealed until the day of the show when winner picks up his/her tickets from the box office, unless otherwise instructed by the Administrator. Instructions for the Meet and Greet will be provided to the winner after he/she has been verified and on the day of the concert.

Prize does not include travel, accommodations or any other associated costs or expenses not expressly named herein. Winners will need to pick up prizes at the concert venue and must show a valid government issued photo ID to collect their tickets. Tickets are non-refundable and non-transferable, cannot be sold or exchanged. Winner must comply with all instructions and protocols required (including, but not limited to, trip itinerary, changes, protocols and requirements to gain access, screenings or background check) and are responsible for all documentation required.

The meet and greet is subject to the artists' schedules and may be canceled or change and therefore, time, duration and all other details are in the sole and absolute discretion of Prize Provider. Instructions for the meet and greet will be provided with tickets at the venue. Photos and video will not be permitted during the meet and greet unless otherwise permitted while present. Meet and Greet is not private and will include other guests along with band members.

You may enter each Sweepstakes, Non-winning entries from one Sweepstakes will not be included in drawings for any other Sweepstakes. Administrator's decisions as to the operation of the Sweepstakes and the selection of potential winners are final and binding in all matters related to the Sweepstakes. Prizes awarded are tickets are winner's use of the tickets is subject to the terms and conditions set forth thereon or governing the use of, and show venue. Winner is required to read the Terms and Conditions for each ticket and show venue carefully.

All prize details are subject to change and in the sole discretion of Prize Provider or representatives and in the event that Administrator is unable to provide a winner with his/her prize(s), the Administrator may elect, to provide winner(s) with the approximate value of such item in cash or award an alternate prize of comparable or greater value. If talent cannot be present, or an event changes, Prize Provider reserves the right to substitute prizes of that are not similar in value on the same dates. The appearance of the artist in connection with any portion of the prize, including the show, is subject to availability and is subject to cancellation; if unable fulfill any portion of the prize, Prize Provider will make commercially reasonable efforts to replace it with a similar prize. If winner or guest is unable to attend for any reason, the winner will not receive any substitution or reimbursement of the prize or portion thereof. All unclaimed prizes or unused portion of the prize shall be forfeited in its entirety. All prize(s) are awarded “AS IS” and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). It is winner's sole responsibility to stay informed about the details including event location, time and any changes regarding the event. Winner must comply with all instructions and protocols required (including, but not limited to, tickets to events or background checks) and are responsible for all documentation required. Winner is required to provide Administrator, Administrator and Prize Provider with his/her and his/her guest's name, residential addresses, telephone number, email address and each must present valid government-issued photo ID (such as license or passport) upon request and at the event. In the event the winner or his/her guest engages in behavior at any time that Sponsor, Administrator or Prize Provider or its representative determines, in their respective sole discretion, is obnoxious, threatening, illegal or intended to annoy, abuse, threaten or harass any other person, the Sponsor, Administrator and Prize Provider reserve the right to terminate the prize, in whole or part, and there will not be any substitution. All prizes will be awarded (assuming sufficient number of eligible entries) subject to the rules herein. Prize Provider reserves right to substitute prizes of equal or greater value or different value; no substitution or transfer of prizes permitted by winner. No costs or expenses incurred by winners are included in the prize. Sponsor, Administrator and Prize Provider are not responsible for any lost, mutilated, or stolen tickets, travel

vouchers or certificates. Neither Sponsor, Administrator nor Prize Provider are responsible for prize utility, quality or otherwise. The winners may be required to provide Sponsor, Administrator and Prize Provider with a valid social security number before the prize(s) will be awarded for tax reporting purposes. An IRS Form 1099 may be issued by Prize Provider in the name of winner(s) for the actual value of the prize(s) received. All prize details not specified in these Official Rules will be determined in Prize Provider's sole and absolute discretion.

Only one prize per person and per household will be awarded. All prize(s) are awarded "as is" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). The prize is non-transferable by the winner(s). All prize details not specified in these Official Rules will be determined in Prize Provider's sole and absolute discretion. All federal, state and/or local taxes, fees, and surcharges are the sole responsibility of the prize winner. Failure to comply with the Official Rules will result in forfeiture of the prize.

6. SELECTION OF WINNERS AND ODDS OF WINNING: Five entrants will be selected for each Sweepstakes from all eligible entries in one random drawing (the "Drawing") received by CrowdRise (the "Potential Winner(s)"). The entrant that is a Canadian resident will have to first answer correctly a skills-based question to be a Potential Winner. The first entrant selected in the Drawing will be the potential Grand Prize Winner and the next four entrants selected will be remaining four potential winners (i.e. winners of two tickets). Should the Grand Prize winner be ineligible for any reason, a new name will be drawn for that prize amongst all eligible entrants, time permitting. The Drawings will take place on the dates listed in the Schedule. In Section 3. Potential Winner(s) are subject to verification by CrowdRise. Odds of winning depend upon the total number of eligible entries you submit and the total number of eligible entries overall that are received for the Promotion. Any attempts to exceed the limit of number of entries into the Promotion by any method, including but not limited to, using multiple email addresses or accounts or robotic entries, are prohibited, and Sponsor reserves the right in its sole discretion to disqualify all suspect entries. An individual may not enter on behalf of another individual or transfer his/her entry to another person. An individual may be required to show proof of ownership of his/her accounts used to enter the Promotion.

7. VERIFICATION OF WINNERS AND DELIVERY OF PRIZES: The Potential Winners will be notified by email within one (1) business days or sooner after verification by CrowdRise or its representative. If there is any inconsistency between any term of the AAA Rules and any term of this Arbitration Agreement, the applicable terms of this Arbitration Agreement will control unless the arbitrator determines that the application of the inconsistent Arbitration Agreement terms would not result in a fundamentally fair arbitration. The arbitrator must also follow the provisions of these Official Rules as a court would. All issues are for the arbitrator to decide, including, but

not limited to, issues relating to the scope, enforceability, and arbitrability of this Arbitration Agreement. Although arbitration proceedings are usually simpler and more streamlined than trials and other judicial proceedings, the arbitrator can award the same damages and relief on an individual basis that a court can award to an individual under these Official Rules and applicable law. Decisions by the arbitrator are enforceable in court and may be overturned by a court only for very limited reasons.

Unless CrowdRise and/or Sponsor, as applicable, and you agree otherwise, any arbitration hearings will take place in a reasonably convenient location for both parties with due consideration of their ability to travel and other pertinent circumstances. If the parties are unable to agree on a location, the determination shall be made by AAA. If your claim is for \$10,000 or less, CrowdRise and/or Sponsor agrees that you may choose whether the arbitration will be conducted solely on the basis of documents submitted to the arbitrator, through a telephonic hearing or by an in-person hearing as established by the AAA Rules. Regardless of the manner in which the arbitration is conducted, the arbitrator shall issue a reasoned written decision sufficient to explain the essential findings and conclusions on which the award is based.

(e) Costs of Arbitration: Payment of all filing, administration, and arbitrator fees (collectively, the “Arbitration Fees”) will be governed by the AAA Rules, unless otherwise provided in this Arbitration Agreement. Any payment of attorneys’ fees will be governed by the AAA Rules.

(f) Confidentiality: All aspects of the arbitration proceeding, and any ruling, decision, or award by the arbitrator, will be strictly confidential for the benefit of all parties.

(g) Severability: If a court or the arbitrator decides that any term or provision of this Arbitration Agreement other than clause (b) above is invalid or unenforceable, the parties agree to replace such term or provision with a term or provision that is valid and enforceable and that comes closest to expressing the intention of the invalid or unenforceable term or provision, and this Arbitration Agreement shall be enforceable as so modified. If a court or the arbitrator decides that any of the provisions of clause (b) is invalid or unenforceable, then the entirety of this Arbitration Agreement shall be null and void. The remainder of these Official Rules will continue to apply.

(h) Conflict: In the event of any conflict between any term or condition in this Section 8 and any term or condition in the CrowdRise Terms and Conditions (<https://www.crowdrise.com/about/terms>), then the applicable term or condition in this Section 8 shall apply.
