Participants (also “entrants”, “they” and “you”) are not limited to the number of Sweepstakes they may enter, by donation and/or for free, or win.**

Please read these Official Rules. By participating in this Promotion, entrant unconditionally agrees to these Official Rules and all decisions by Sponsor, which are final and binding in all matters related to these Sweepstakes. To win the prize(s), you must comply with all facets of the Official Rules and all decisions by Sponsor and Prize Provider.

**1. ELIGIBILITY:** The Promotion is open to individuals who agree to these Official Rules who are legal residents of the 50 United States or the District of Columbia and Puerto Rico or Canada (excluding Quebec) and any other country where permitted by law without restriction; the Sweepstakes is not open to residents of Belgium, Cuba, Czech Republic, Finland, Iran, Iraq, Italy, Malta, North Korea, Norway, Quebec, Singapore, Sudan, Syria, Thailand; any additional countries on the United States list of embargoed countries, and all other countries where prohibited or restricted by law (the “Eligibility Area”). To enter, you must also be at least age 18 or the age of majority in your jurisdiction, whichever is greater or you may enter on behalf of your child or legal ward, consenting to these Official Rules on their behalf so long as you are (and the minor is also) compliant with all the Rules and Restrictions herein. Do not enter the Promotion if your country of residence, age or any other rule or law prohibits or restricts you from entering or participating in the Promotion, or prohibits, restricts or limits the award of the prize. Sponsor makes no representations or warranties that a leaderboard, donation scroll box on CrowdRise.com, notification or elsewhere will be updated on a real-time basis, will always be accurate or will represent the official standings, results or leaders of the Sweepstakes at any time before, during or after the Promotion Period. The leaderboard, donation scroll lists and any similar lists tallying donations are unofficial tallies of the amounts of donations in a campaign and may not accurately reflect the donations made based on a variety of factors. Results of the Sweepstakes are not official until Sponsor expressly announces the final results and verifies the winners.

**\*Note:** you are not limited to the number of Sweepstakes you may enter; you may enter any Sweepstakes a maximum of five hundred (500) times total; you may enter any Sweepstakes by donation or you may enter for free; you are not limited to the number of Sweepstakes you may win.

**\*Note:** all references to dollars are in United States currency.

- 3. HOW TO ENTER ANY SWEEPSTAKES:** During the Sweepstakes Period, you may enter by either of the following methods or a combination thereof:

**(a) Method One, To Enter by Donation:**

- (1) Go to CrowdRise (the “Website”) here: <https://www.crowdrise.com/wesanderson> and follow the on-screen instructions to donate at least ten dollars (\$10) online during the Entry Period(s) outlined in the Sweepstakes Schedule in Section 2 above to receive an entry to win or multiple entries, and for every Ten Dollars (\$10.00 USD) that you donate during any available Entry Period, you will receive one (1) entry to win that respective Sweepstakes.

**Requirements and Limits:**

Donor receives the maximum number of entries for each donation per the above. Donations do not need to be exact or multiples of the increments listed above. In other words, \$10 and \$11 donations get one entry, \$20 and \$21 get two entries. You may donate more than one time. Each donation you make separately on CrowdRise is separate for purposes of counting entries. In other words, if you make 2 separate donations of \$15 each, you get two entries (not three entries, which would have been the case if you had made one donation of \$30).

Donations must be made on the Website using a credit card and successfully processed to completion (and not subject to any chargebacks or disputes) through CrowdRise and its third party payment processor during the Entry Period to count toward the Sweepstakes. submitted and received during the Sweepstakes Period and must be complete and accurate, or your entry is automatically void.

Important: To be complete and accurate and entered for free, the name of the Promotion in your form must contain the correct information which is as follows:

#### Requirements and Limits:

All entries are subject to verification of eligibility before a prize can be awarded. For example, if your birthdate or address entered on the Website or provided in your email does not meet eligibility requirements, your entry is automatically void; donation(s) will not be refunded automatically. Your receipt and any confirmation email you receive are not confirmation of entry.

Those who do not follow all of the instructions, provide the required information in their donation or entry form, or abide by these Official Rules or other instructions of Sponsor or Prize Provider may be disqualified at either of Sponsor's or Prize Provider's sole and absolute discretion. All entries that are late, illegible, incomplete, damaged, destroyed, forged or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at either of Sponsor's or Prize Provider's sole and absolute discretion.

In the event of a dispute as to the identity of any entrant, the entry will be deemed submitted by the account holder of the email from which it was sent but only if such person is otherwise eligible. The "account holder" is the person assigned an email address or username by the entity responsible for assigning it (e.g., Gmail). Winner may be required to show proof of being the registered account holder. If a dispute cannot be resolved to the Sponsor's and Prize Provider's satisfaction, the entry will be deemed ineligible. Sponsor and Prize Provider's and affiliated entities are not responsible for lost, misdirected, misplaced, stolen, tampered with, deleted, or invalid entries.

You may enter more than one Sweepstakes. Non-winning entries from one Sweepstakes will not be included in drawings for any other Sweepstakes. Sponsor's decisions as to the operation of the Sweepstakes and the selection of potential winners are final and binding in all matters related to the Sweepstakes.

At the end of each Sweepstakes, Sponsor or its representative will conduct a random drawing and all selected entrants are required to correctly answer a mathematical skill-based test question administered by Sponsor prior to being declared a Potential Winner. A Potential Winner shall not receive a Prize until he/she is verified (see Section 6 below) and declared an Official Winner by Sponsor ("Official Winner" or "Winner").

**There is a limit of five hundred (500) total entries permitted per entrant, per Sweepstakes, regardless of method of entry, during the Promotion Period.**

#### 4. PRIZES:

##### **Sweepstakes One; Prize One:**

There will be one (1) winner. The prize is a trip for winner and winner's guest to London, England featuring: meet Wes Anderson; get a tour of the Isle of Dogs sets and production to see how the film is being made; record the 'voice' of a dog in the film, directed by Wes (barking, howling & whimpering may be required); and receive one of the animatronic puppet miniatures of a dog from the film, after production has wrapped. Restrictions apply.

**Sweepstakes Two; Prize Two:**

Fifty (50) Winners will receive a Criterion collection DVD signed by Wes. Restrictions apply.

**Sweepstakes Three; Prize Three:**

Twenty-five (25) Winners will receive a Criterion Collection DVD signed by Wes and a signed copy of "The Wes Anderson Collection" book. Restrictions apply.

**Restrictions:**

The Approximate Retail Value ("ARV") for each prize is: Prize One: four thousand five hundred dollars (\$4,500); Prize Two: seventy five dollars (\$75) each; Prize Three: one hundred fifty dollars (\$150) each. Taxes and fees, and all additional costs that may be incurred, if any, are the sole responsibility of winner. All currency is in US dollars.

**Prize One:**

There will be one (1) Potential Winner (as defined in Section 5 below). The prize is: a 3-day, 2-night trip for winner and winner's guest to go to London, England featuring the opportunity to meet Wes Anderson, tour the "Isle of Dogs" (the "Film") sets and record the 'voice' of a dog in the Film (the "Trip" or "Prize") and receive an animatronic puppet miniatures of a dog from the Film. ("Prize" or "Trip"). Trip will take place during a date and time specified by Prize Provider, and all such details will be communicated to the Winner after the end of the Promotion, and must take place no later than one year from date of selection of the Winner. Winner must travel on the exact dates and itinerary specified by Sponsor. Sponsor and Prize Provider are not responsible for any cancellations, delays or changes to the Trip in whole or part including the presence of talent, Wes Anderson, which is wholly dependent on his schedule and other factors, which may affect this portion of the Trip; winner will not be compensated in the event of cancellation of the meet and greet with Wes Anderson portion of the Trip and there will be no make up prize. The time, duration and details are in the sole and absolute discretion of Prize Provider and subject to change; if canceled, Prize Provider will make commercially reasonable efforts to award a similar experience of equal or greater value at the time of the Trip. Winner's guest must be 18 years of age or older, unless if winner is the parent or legal guardian and pre-approved by Prize Provider and Sponsor. Trip includes: payment toward round-trip coach air transportation for winner and one (1) guest to and from a major commercial airport ("U.S. Gateway City") in the 50 United States near the winner's primary residence, up to one thousand five hundred dollars (\$1,500) per ticket and two (2) night's stay at a hotel (one room, standard accommodations, double occupancy) selected by the Prize Provider. Selection of airline carrier and U.S. Gateway City, winner's primary residence and itinerary is at sole discretion of Prize Provider. All travel expenses not described herein as being awarded, including, but not limited to, incidental hotel expenses, phone expenses, meals, gas, ground transportation, gratuities, and souvenirs, are the sole responsibility of the Winner. Any and all costs associated with reaching the departure city will be the Winner's sole responsibility. Transportation to and from the U.S Gateway City is the sole responsibility of Winner and his or her guest and is not included in prize. Winner and his/her guest must book travel through the assistance of Sponsor or its representative at least six (6) weeks in advance of departure, unless stated otherwise by Prize Provider, and travel is subject to availability. Blackout dates may apply and this is determined at the sole discretion of Prize Provider and/or Sponsor. Certain additional restrictions may apply. All travel must be completed on dates specified by Prize Provider, which will be provided to Winner. Winner and his/her guest must

travel on the same itinerary. Prize Provider will not replace any lost or stolen tickets, travel vouchers, or certificates. Winner's use of the airline tickets or any other tickets is subject to the terms and conditions set forth thereon or governing its use. Winner is required to read the Terms and Conditions for each ticket carefully. Once booked, no change, extension, or substitution of Trip dates is permitted, except by Prize Provider at its sole discretion. Tickets are non-refundable and not redeemable for cash or credit. Tickets may not be transferred or sold to a third party. Tickets may not be upgraded, even if with miles or redeemed for miles. Winner and guest are responsible for obtaining all necessary and required travel documentation, authorizations, and travel and health insurance. Travel arrangements must be made through Prize Provider's agent and Prize Provider shall determine airline and flight itinerary in its sole discretion. If winner resides within a one-hundred (100) mile radius of the hotel or event, in lieu of the airfare, winner will receive one (1) round-trip ground transportation of Prize Providers' choice for winner and guest between winner's residence and the event. Accommodations are subject to change based on availability and in Prize Provider's sole discretion. If for any reason any portion of the Prize does not occur, such portion will be forfeited with no compensation being paid in exchange thereof. Prize Provider requires Potential Winner and guest to sign a non-disclosure agreement and Affidavit of Eligibility, Liability and Publicity Release or declaration, to participate and pass a background check to verify the winner's identity and security screenings to ensure the winner's compliance with the law and safety of others, in the sole discretion of Prize Provider and any other requirements to claim the prize. All aspects of the voice recording of a dog in the Film are subject to the requirements and approval of the Prize Provider who may withhold the prize, in its sole and absolute discretion. Winner may not have the opportunity to schedule conflicts and other factors. This prize does not get extended to the guest of the winner. Winner permits the content to be used by Prize Provider but there is no guarantee that Winner's recording will actually appear in the final version of the Film. The recording itself will not be directed by any certain individual from the Film and not by Wes Anderson.

The Approximate Retail Value ("ARV") of prize is four thousand five hundred dollars (\$4,500 USD), depending on winner's primary residence and fares at time of departure. The actual retail value may be different than the approximate retail value or from that pictured in advertising and the winner will not be compensated for the difference. No cash redemption of the prize. No transfer of the prize. Prize may not be substituted, except by Prize Provider for a prize of equal or greater value. Taxes on the prize are the sole responsibility of the Potential Winner. Acceptance of a prize constitutes permission for the Sponsor, Prize Provider, and its and their designees to use winner's name and likeness for advertising, promotional and other purposes in any and all media now and hereafter known without additional compensation unless prohibited by law. By accepting the prize, Potential Winner (including Winner's guest) acknowledges and accepts sole liability for the inherently dangerous nature of and risks of traveling, including but not limited to personal injury and/or death. By accepting a prize, the Winner (including Winner's guest) agrees to release Prize Provider, Sponsor, any Internet access providers and each of their respective parent companies, affiliates, subsidiaries, divisions, advertising and promotion agencies, and all of their respective employees, directors, officers, shareholders, agents, successors or assigns (collectively "Released Parties"), from any and all liability, loss or damage of any kind incurred with respect to participation in this Sweepstakes, including, without limitation, the awarding, receipt, possession, and/or use or misuse of any prize, or participation in prize-related activities, including but not limited to travel related thereto. Winner (and winner's guest) acknowledges that neither Released Parties nor their directors, employees, or agents, have made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to the prize, including but not limited to its quality, mechanical condition or fitness for a particular purpose. Any and all warranties and/or guarantees on a prize (if any) are subject to the respective manufacturers' terms thereof, and winners agree to look solely to such manufacturers for any such warranty and/or guarantee.

Winner must comply with all instructions and protocols required (including, but not limited to, trip itinerary, changes, protocols and requirements to gain access, screenings or background check) and are responsible for all documentation required. Winner and any guest of such winner is required to provide Sponsor and Prize Provider with his/her name, residential addresses, telephone number, email address and must present valid government-issued photo ID (such as a passport) upon request and during the Trip and at any venue. In the event the winner and such winner's guest engages in behavior at any time that Sponsor, Prize Provider or their representative determines, in their sole discretion, is obnoxious, threatening, illegal or intended to annoy, abuse, threaten or harass any other person, the Sponsor and Prize Provider reserves the right to terminate the prize, in whole or part, and there will not be any substitution. The prize will be awarded (assuming sufficient number of eligible entries) subject to the rules herein. Winner and guest may be required to provide Sponsor with a valid social security number before the prize(s) will be awarded for tax reporting purposes. An IRS Form 1099 may be issued in the name of winner(s) for the actual value of the prize(s) received. All prize details not specified in these Official Rules will be determined in each of Sponsor's and Prize Provider's respective sole and absolute discretion.

Winner to receive a follow-up email with instructions from Sponsor with additional prize details about travel and the opportunity to record the 'voice' of a dog in the Film, for which there is no guarantee that the winner's voice or content will be used in the film. It is winner's sole responsibility to stay informed.

Shipping will only be to the Official Winner's physical mailing address (no P.O. Boxes) that entrant used at the time of entry upon registration on CrowdRise.com and must be within the Eligibility Area with no exceptions. Shipping date six to eight months after production of the Film has ended and the exact date is to be determined by Sponsor. Shipping costs shall be no greater than twenty dollars (\$20) and all additional costs that may be incurred, if any, are the sole responsibility of the Winner. Neither Sponsor nor Prize Provider are responsible for prize utility, quality, damages of any kind during shipping or anytime thereafter.

- 5. SELECTION WINNERS AND ODDS OF WINNING:** The Sweepstakes will end on the dates specified in the Schedule in Section 2 and upon ending, Sponsor or its representative will conduct a random drawing for each Sweepstakes (the "Drawing") from all eligible entries to determine one (1) Potential Winner for Sweepstakes One, the fifty (50) Potential Winners in Sweepstakes Two and twenty-five (25) Potential Winners in Sweepstakes Three. The selected entrants are required to correctly answer a mathematical skill-based test question administered by Sponsor prior to being declared a Potential Winner. Entries are subject to verification by Sponsor and potential Winners are not declared final and shall not receive a prize until verified by Sponsor. Sponsor's decisions are final and binding on all matters relating to this Sweepstakes. Odds of winning depend upon the total number of eligible entries received. Any attempts to exceed the limit of number of entries into the Sweepstakes by any method, including but not limited to, using multiple email addresses or accounts or robotic entries, are prohibited and Sponsor reserves the right in its sole discretion to disqualify all suspect entries. An individual may not enter on behalf of another individual or transfer his/her entry to another person. An individual may be required to show proof of ownership of his/her accounts used to enter this Sweepstakes.
- 6. VERIFICATION OF WINNERS AND DELIVERY OF PRIZES:** Potential winner(s) will notified by email within one (1) business day after verification by Sponsor or its representative. A potential winner is subject to verification by Sponsor whose decisions are final and binding in all matters related to the Sweepstakes. An entrant is not a winner of any prize unless and until the entrant's eligibility has been verified and the entrant has received notice from Sponsor that he/she has won the prize, even if any information on Sponsor's Website, indicates that

an entrant has won. Potential winner(s) are required to provide Sponsor and Prize Provider his/her legal name, residential address, telephone number, email address and valid government issued photo ID (driver's license, passport, military ID or similar proof of identity that is acceptable to Sponsor in its sole discretion). Potential winner will be required to sign a non-disclosure agreement and an affidavit of eligibility/liability release (which affirms that he/she has complied with these Official Rules), Form W-9 or IRS Form 1099 and a publicity release (where permitted by law), all of which, if issued, must be completed, signed, notarized and returned within four (4) business days from date of issuance or the prize will be forfeited and may be awarded to an alternate winner. Winner's guest will also be required to complete, sign, and notarize a liability and publicity release that Potential Winner must return to Sponsor within four (4) business days. If the potential winner refuses to provide his/her Social Security Number for such prize within two (2) business days after request is made for the same, said winner will be disqualified and an alternate winner will be selected. If the prize is declined, the prize or prize notification is returned as undeliverable, or in the event of noncompliance with these Official Rules and these requirements herein, the prize will be forfeited and may be awarded to an alternate winner in Sponsor's sole discretion. If potential winner forfeits a prize, Sponsor may, but is not required to, select one new potential winner.

Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any participation in the Sweepstakes that occurs after Sponsor's computer or other systems have failed will be deemed defective and will not be honored. Additional paperwork, releases, background check or screenings, will also be required before a prize can be awarded. The person selected by the winner as his/her intended travel companion will be required to sign and return the necessary paperwork for a background check, prior to date of travel, within the same time period. As a condition of accompanying winner on the Trip, guest will be required to consent to a background check; and, failure to sign such consents and authorizations and/or to furnish all required information will result in person selected by winner as his/her travel companion not being allowed to accompany winner on Trip. In addition, Sponsor and Prize Provider reserve the right in their sole discretion, to refuse to allow person selected as winner's guest to accompany winner on the Trip if the results of such background check reveal that such initially selected travel companion has been convicted of a felony or a crime of moral turpitude, as determined by Sponsor and Prize Provider in their sole discretion. If Sponsor and Prize Provider determine, in their sole discretion, that the selected travel companion is not permitted to accompany the winner on the Trip based on results of the background check, winner may choose an alternate guest (who will also be subject to a background check).
