

**THE RECLAIMED RUST BOX SET SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE, DONATION OR FUNDRAISING OF ANY KIND IS REQUIRED TO ENTER OR WIN. A PURCHASE, DONATION OR FUNDRAISING WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Reclaimed Rust Box Set Sweepstakes (hereinafter, the “Sweepstakes”) is a sweepstakes sponsored by the All Within My Hands Foundation (“Sponsor”) and hosted on a crowdfunding platform operated by GoFundMe, Inc. (“GoFundMe”) called GoFundMe Charity (“GFM Charity Platform”). Sponsor is responsible for administering the Sweepstakes and providing the prize. Donations made in the Sweepstakes (as defined below) go to the All Within My Hands Foundation, EIN 81-4258668, a nonprofit organization qualified under Section 501(c)(3) of the U.S. Internal Revenue Code of 1986, as amended. The mission of the Sweepstakes is here: <https://charity.gofundme.com/o/en/campaign/reclaimed-rust-box-set> (the “Campaign”). Your participation in the Sweepstakes means that you unconditionally agree to these Official Rules and all decisions by Sponsor, which are final and binding in all matters related to the Sweepstakes. **THE SWEEPSTAKES IS VOID OUTSIDE OF THE ELIGIBILITY AREA (DEFINED BELOW), WHERE PROHIBITED OR RESTRICTED BY LAW AND WHERE BONDING, REGISTRATION, OR OTHER REQUIREMENTS WOULD BE REQUIRED BUT HAVE NOT BEEN MET, OR WHERE THE METHODS OF ENTRY SET FORTH BELOW WOULD BE DEEMED CONSIDERATION. ALL APPLICABLE FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS APPLY.**

THESE OFFICIAL RULES (“OFFICIAL RULES”) CONTAIN AN ARBITRATION AGREEMENT, WHICH WILL, WITH LIMITED EXCEPTION, REQUIRE YOU TO SUBMIT CLAIMS YOU HAVE AGAINST SPONSOR, GOFUNDME AND/OR THE GFM CHARITY PLATFORM TO BINDING AND FINAL ARBITRATION. UNDER THE ARBITRATION AGREEMENT, (1) YOU WILL ONLY BE PERMITTED TO PURSUE CLAIMS AGAINST SPONSOR, GOFUNDME OR THE GFM CHARITY PLATFORM ON AN INDIVIDUAL BASIS, NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY CLASS OR REPRESENTATIVE ACTION OR PROCEEDING, AND (2) YOU WILL ONLY BE PERMITTED TO SEEK RELIEF (INCLUDING MONETARY, INJUNCTIVE, AND DECLARATORY RELIEF) ON AN INDIVIDUAL BASIS.

The GoFundMe Terms and Conditions (<https://www.gofundme.com/terms>) and Privacy Policy (<https://www.gofundme.com/privacy/>) apply to the Sweepstakes and all entries and donations received in connection therewith. In the event of a conflict between these Official Rules and either the GoFundMe Terms and Conditions or the Privacy Policy, these Official Rules govern and control only to the extent of such conflict.

1. ELIGIBILITY:

Entrant Eligibility: The Sweepstakes is open to individuals who agree to these Official Rules who are legal residents of the 50 United States and the District of Columbia (collectively, the “Eligibility Area”). To enter, you must also be at least age 18 or the age of majority in your jurisdiction, whichever is greater. Do not enter the Sweepstakes if your country of residence, age or any other rule or law prohibits or restricts you from entering or participating in the Sweepstakes, or prohibits, restricts or limits the award of the prize. You must be able to accept the award of the prize without rules or restrictions imposed by the jurisdiction in which you live. Employees of Sponsor, GoFundMe, talent and their respective parents, affiliate companies, subsidiaries, agents, judges, advertising and promotion agencies and anyone involved in the development or execution of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children and their respective spouses, regardless of where they live) and household members of each such employee, whether or not related, are not eligible to participate. All federal, state, and local laws, rules and regulations apply. Entrants and entries are subject to all local rules. Void outside of the Eligibility Area and where prohibited by law. All donations made in connection with the Sweepstakes are governed by the Official Rules. The GoFundMe Terms and Conditions (<https://www.gofundme.com/terms>) apply. In the event of a conflict between these Official Rules and the GoFundMe Terms and Conditions, these Official Rules govern and control only to the extent of such conflict.

By entering, each entrant understands and agrees that, if selected as the Potential Winner (as defined in Section 5 below), they and their guest may be required to consent to a background check, a photography/video release, and/or an Affidavit of Eligibility/Release or declaration and of Liability/Publicity Release; and, failure to sign such consents and authorizations and/or to furnish all required information will result in disqualification. In addition, Sponsor reserves the right in their sole discretion, to disqualify the Potential Winner if the results of such background check reveal that the Potential Winner (or guest) is not eligible to participate in the Sweepstakes, is dangerous or otherwise constitutes a threat, or has been convicted of a felony or a crime of moral turpitude, as determined by Sponsor in its sole discretion.

Donation Eligibility: In addition to any other requirements and restrictions set forth herein, for any donations made in connection with the Sweepstakes, the minimum donation is \$10 per transaction. Additionally, donations must be made on the GFM Charity website at <https://charity.gofundme.com> (the “Website”) via the Campaign using a credit card through GFM Charity and its third-party payment processor during the Sweepstakes Period (defined below) and successfully processed to completion through GFM Charity and its third-party payment processor(s) **before** the end of the Sweepstakes Period in order to count as an entry for the Sweepstakes. **Donations can take time to process.** Donations made outside of the Campaign, outside the Sweepstakes Period and/or offline, even if recorded on the Website, including, but not limited to, donations by cash, credit card, money order or an ineligible fundraising page on the Website, or any other donations not successfully processed online via credit card (“offline donations”) or that are otherwise not in compliance with these Official Rules are not eligible and will not be counted toward the Sweepstakes. Assurance of delivery and processing of donations is the sole responsibility of the entrant.

Sponsor, or its designee, has the right to verify any donation, and any donation that is subject to chargeback or dispute may not count as an entry for the Sweepstakes. Sponsor is not responsible for any delays in processing any donations. Results of the Sweepstakes are not official until Sponsor or its duly authorized representative, verifies the winner(s).

Donations are non-refundable. Please note that although you may receive entries for the full amount of your eligible donation in accordance with the terms in these Official Rules, the ultimate recipient of your donation may receive less than the full amount that you donate after the deduction of administrative and processing fees in accordance with the GoFundMe Terms and Conditions.

2. SWEEPSTAKES PERIOD: The Sweepstakes begins on July 21, 2020 at 12:00:00pm Eastern Time (ET) and ends on August 11, 2020 at 11:59:59pm ET, such period referred to herein as the “Sweepstakes Period”. The GFM Charity Platform’s server and computer clock is the official time-keeping device for the Sweepstakes.

3. HOW TO ENTER AND WIN: Your participation in the Sweepstakes is voluntary and does not require you to purchase anything from the Sponsor or GFM Charity or to make any donations or perform any fundraising through GFM Charity. During the Sweepstakes Period, enter the Sweepstakes as follows:

- (a) **Method One: To Enter by Donation:** Donate at least ten dollars (\$10) online to the Campaign here: <https://charity.gofundme.com/o/en/campaign/reclaimed-rust-box-set>. To determine the number of entries in connection with each donation, your donation is broken down into ten dollar (\$10) increments, with each ten dollar (\$10) increment constituting one (1) entry. Donations or dollars raised do not need to be exact or multiples of the increments listed above. In other words, \$10 and \$11 donations get one entry; \$60 and \$61 get six entries. You may donate more than one (1) time, provided that your total entries (regardless of method of entry) do not exceed the entry limit set forth in these Official Rules. Each donation you make separately on <https://charity.gofundme.com> is separate for purposes of counting entries. In other words, if you make 2 separate donations of \$15 each, you get two entries (not three entries, which would be the case if you make one donation of \$30).
- (b) **Method Two: To Enter for Free:** During the Sweepstakes Period, go to: <https://charity.gofundme.com/FreeAlternateMethodofEntry> and follow the on-screen instructions to submit a “Free Alternate Method of Entry” form by entering your information and the name of the

Sweepstakes identified in these Official Rules which is: Reclaimed Rust Box Set Sweepstakes. The Name of Sweepstakes field can be left blank. Each form you submit constitutes one (1) entry. You may submit more than one entry, provided you do not exceed the maximum number of entries.

There is a limit of fifty (50) entries total permitted per person, per sweepstakes, regardless of method of entry, during each Sweepstakes Period.

Regardless of method of entry, all entries are subject to verification of eligibility before a prize can be awarded. For example, if your birthdate or address entered on the Website or otherwise during the entry process does not meet eligibility requirements, your entry is automatically void. Your receipt and any confirmation email you receive are not confirmation of entry.

Those who do not provide the required information in their donation or entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified at the sole and absolute discretion of Sponsor. All entries that are late, illegible, incomplete, damaged, destroyed, forged or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion.

In the event of a dispute as to the identity of any entrant, the entry will be deemed submitted by the account holder of the email from which it was sent but only if such person is otherwise eligible. The "account holder" is the person assigned an email address or username by the entity responsible for assigning it (*e.g.*, Gmail). Potential Winner(s) (defined below) may be required to show proof of being the registered account holder. If a dispute cannot be resolved to Sponsor's satisfaction, the entry will be deemed ineligible.

Receipts will be issued to all donors, however, donations may not be tax-deductible and the winner(s)'s prize may be taxable. It is the individual entrant's sole responsibility to determine the tax-consequences of their donations. Every entrant agrees that any information provided by Sponsor or the GFM Charity Platform shall not be considered tax or legal advice. Every participant is advised to consult a professional, including a tax professional, if advice is desired regarding his/her participation herein.

4. PRIZE: There will be one (1) Official Winner, who will receive a 'Reclaimed Rust: The Four-Wheeled Creations of James Hetfield Limited Edition Box Set.

The box set includes a coffee table book featuring the Reclaimed Rust metal shield on the leatherette book cover, measuring 12" x 9" and 192 pages in length; a numbered, deluxe clamshell case; a signature card personally signed by James Hetfield; four (4) lithographs featuring images of the Black Pearl, the Skyscraper, the Aquarius, and the Slow Burn (all cars included in the book); a metal car plaque; a shop towel; a keychain; an original poster featuring the Blackjack (one of the vehicles featured in the book), and commemorative Reclaimed Rust guitar picks created for the original show at the Petersen Automotive Museum.

The Approximate Retail Value ("ARV") of all prizes: Four hundred dollars (\$400).

The prize is non-transferable by the winner(s), and no cash equivalent or substitution of prize is offered, except at the sole discretion of Sponsor. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. In order to receive a prize, winner(s) may be required to provide proof of identification or eligibility. Winner(s) will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prizes they receive. All prize(s) are awarded "as is" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Shipping will only be to the verified winner(s)'s physical mailing address (no P.O. Boxes) used at the time of entry, which must be in the Eligibility Area, except in Sponsor's sole and absolute discretion. Neither Sponsor, nor GoFundMe, Inc. are or shall be responsible or liable for late, lost, misdirected or unsuccessful efforts to notify the Potential Winner(s) or for the prize utility, quality, or damages of any kind during shipping or anytime thereafter. Shipping date shall be within six (6) months after the Promotion has ended, and the exact date is to be determined by Sponsor. In the event that Sponsor is unable to provide a winner with their prize(s) or any portion thereof, the Sponsor may elect, at its sole discretion, to provide such winner with the approximate value of such item in cash or award an alternate prize of comparable or greater value, as determined by Sponsor in its sole discretion. No cash equivalent or other substitution of

prize is offered.

All prize details not specified in these Official Rules will be determined in Sponsor or its representative's sole and absolute discretion.

5. SELECTION AND VERIFICATION OF WINNER(S) AND ODDS OF WINNING: Within one (1) day of the end of the Sweepstakes, the sweepstakes winner(s) will be determined by selecting one entrant in a random drawing. The Potential Winner(s) will be notified by Sponsor or GoFundMe via e-mail. Odds of winning depend upon the total number of eligible entries you submit and the total number of eligible entries overall that are received for the Sweepstakes. Any attempts to exceed the limit of number of entries into the Sweepstakes by any method, including but not limited to, using multiple email addresses or accounts or robotic entries, are prohibited, and Sponsor reserves the right in its sole discretion to disqualify all suspect entries. An individual may not enter on behalf of another individual or transfer their entry to another person. An individual may be required to show proof of ownership of their accounts used to enter the Sweepstakes. The Potential Winner(s) will be notified by email, at the email address associated with entrant's GFM Charity Platform account or otherwise entered during the entry process, within one (1) day after verification by Sponsor or its representative. If any Potential Winner(s) cannot be contacted within seven (7) days after the first attempt to contact them, an alternate entrant may be selected in their place at random from all eligible entries received. Potential Winner(s) are subject to verification by Sponsor or its designee, and may be required to provide Sponsor and/or the GFM Charity Platform their name, residential address, telephone number, email address and valid photo ID. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Potential Winner(s) may also be required to sign a declaration or affidavit of eligibility and liability release (and, where permitted, a publicity release) and Form W-9 (or other applicable filing) concerning the prize. If any Potential Winner is not verified by Sponsor, cannot be contacted within seven (7) days, fails to return any and all requested documentation within seven (7) days from notification (whether or not such Potential Winner actually receives that notification), is otherwise ineligible, or refuses the prize, then such Potential Winner forfeits the prize in its entirety. Except where prohibited, participation in the Sweepstakes constitutes each winner's consent to Sponsor's and the GFM Charity Platform's and their respective agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state/province for advertising, promotional, and other purposes in any manner, in any and all media, now known or hereinafter devised, worldwide, in perpetuity, without further payment or consideration, notification, or permission (unless prohibited by law), and by participating in the Sweepstakes, you further agree to execute any specific consent needed or requested by Sponsor or GFM Charity or their respective designees in furtherance of such use. Additional paperwork, releases, background checks or screenings, to the extent allowed by law, may also be required before a prize can be awarded.

6. RELEASE; LIMITATIONS OF LIABILITY; GENERAL CONDITIONS: Sponsor reserves the right to modify, suspend, cancel, or discontinue any Sweepstakes at any time for any reason, including without limitation to comply with applicable laws, rules, and regulations, and to take any actions Sponsor deems necessary, in its sole discretion, to protect its users, business partners, or business or the public or if any virus, bug, technical failures, unauthorized human intervention or other causes beyond Sponsor's control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes. In the event of such cancellation, termination or suspension, Sponsor will use reasonable efforts to post a notification and, if winner(s) can be selected among all eligible, non-suspect entries received prior to such time, winner(s) will be selected. Sponsor, GoFundMe, and the GFM Charity Platform, and their respective parents, affiliates, subsidiaries and advertising and promotion agencies and all of their respective officers, directors, shareholders, partnership, members, principals, employees, agents, contractors or suppliers, or its advertising and promotion agencies (collectively, "Released Parties") are not responsible for late, lost, stolen, damaged, garbled, incomplete, mistyped, misaddressed or misdirected entries, emails, mail or communications; for errors, omissions, interruptions, deletions, defects, or delays in operations or transmission of information, in each case whether arising by way of technical or other failures or malfunctions of computer hardware, software, communications devices; or for transmission lines or data corruption, theft, destruction, unauthorized access to or alteration of entry materials, loss or otherwise; or for any delays in payment processing, including without limitation related to individuals who attempt to enter the Sweepstakes by donating in accordance with Section 3(a) above. Further, Released Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email account

to receive email messages or insufficient space on entrant's computer. The use of automated software or computer programs to register or to enter the Sweepstakes is prohibited, and any entrant who uses or attempts to use such methods to register or to enter will be disqualified. Released Parties disclaim any liability for damage to any computer system resulting from participation in, or accessing or downloading information in connection with, the Sweepstakes. Sponsor and GFM Charity reserve the right to disqualify any entrant (and their Sweepstakes entry) from the Sweepstakes, any other promotions conducted now or in the future by Sponsor or GoFundMe or any of their affiliates if he/she tampers with the entry process or if their fraud or misconduct affects the integrity of the Sweepstakes or if they engage in any inappropriate or unacceptable behavior in connection with the Sweepstakes. Sponsor reserves the right to correct clerical or typographical errors in promotional materials, including without limitation these Official Rules. By participating in the Sweepstakes, each entrant releases and holds harmless the Released Parties from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, and claims based on publicity rights, copyright, trademark, defamation or invasion of privacy, arising out of participation in the Sweepstakes or entries that are ineligible (including, if entry is made by donation, if not processed prior to the end of the Sweepstakes Period). By accepting the prize, winner(s) agrees to release Released Parties, from any and all liability, loss or damages arising from or in connection with the awarding, receipt and/or use or misuse of prize or participation in any prize-related activity. All Sweepstakes participants acknowledge and agree that normal Internet access, phone and usage charges imposed by their online, phone or similar providers may apply in order to participate in the Sweepstakes and accept the prize. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. The Sweepstakes and all disputes, claims or controversies arising from these Official Rules, shall be governed by California law, without regard to its conflict of laws provisions.

IF YOU ARE A CALIFORNIA RESIDENT, YOU WAIVE ANY AND ALL RIGHTS UNDER SECTION 1542 OF THE CIVIL CODE OF THE STATE OF CALIFORNIA, WHICH PROVIDES AS FOLLOWS: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, AND THAT IF KNOWN BY HIM OR HER WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY." You expressly waive and release any right or benefit which you have or may have under Section 1542 of the Civil Code of the State of California, to the full extent that you may waive all such rights and benefits pertaining to the matters released here. In connection with such waiver and relinquishment, you acknowledge that you are aware that you may hereafter discover claims presently unknown or unsuspected, or facts in addition to or different from those which you now know or believe to be true, with respect to the matters released herein; nevertheless, it is your intention through this release to fully and finally and forever settle and release all such matters and claims relative thereto, which do not exist, may exist or heretofore have existed between yourself and the Released Parties related to the Sweepstakes. The release herein given shall be and remain in effect as a full and complete release of such claims and matters notwithstanding the discovery or existence of any such additional or different claims or facts relative thereto.

7. ARBITRATION AGREEMENT; DISPUTE RESOLUTION BY BINDING ARBITRATION:

PLEASE READ THIS SECTION CAREFULLY AS IT AFFECTS YOUR RIGHTS.

(a) Agreement to Arbitrate: This Section is referred to in these Official Rules as the "Arbitration Agreement." You agree that any and all disputes or claims that have arisen or may arise between you and GFM Charity or Sponsor, whether arising out of or relating to these Official Rules, the Sweepstakes, your participation in the Sweepstakes, the prize, acceptance, possession, use or misuse of the prize, any advertising, or any aspect of the relationship between us, shall be resolved exclusively through final and binding arbitration, rather than a court, in accordance with the terms of this Arbitration Agreement, except that you may assert individual claims in small claims court, if your claims qualify. Further, this Arbitration Agreement does not preclude you from bringing issues to the attention of federal, state or local agencies, and such agencies can, if the law allows, seek relief against us on your behalf. You agree that, by participating in the Sweepstakes, you,

Sponsor, GoFundMe and the GFM Charity Platform, are each waiving the right to a trial by jury or to participate in a class action. Your rights will be determined by a neutral arbitrator, not a judge or jury. The Federal Arbitration Act governs the interpretation and enforcement of this Arbitration Agreement.

(b) Prohibition of Class and Representative Actions and Non-Individualized Relief: ***YOU, GFM CHARITY AND SPONSOR AGREE THAT EACH OF US MAY BRING CLAIMS AGAINST THE OTHER ONLY ON AN INDIVIDUAL BASIS AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE ACTION OR PROCEEDING. UNLESS BOTH YOU AND GFM CHARITY AND SPONSOR, AS APPLICABLE, AGREE OTHERWISE, THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN MORE THAN ONE PERSON'S OR PARTY'S CLAIMS AND MAY NOT OTHERWISE PRESIDE OVER ANY FORM OF A CONSOLIDATED, REPRESENTATIVE, OR CLASS PROCEEDING. ALSO, THE ARBITRATOR MAY AWARD RELIEF (INCLUDING MONETARY, INJUNCTIVE, AND DECLARATORY RELIEF) ONLY IN FAVOR OF THE INDIVIDUAL PARTY SEEKING RELIEF AND ONLY TO THE EXTENT NECESSARY TO PROVIDE RELIEF NECESSITATED BY THAT PARTY'S INDIVIDUAL CLAIM(S).***

(c) Pre-Arbitration Dispute Resolution: Sponsor and the GFM Charity Platform are always interested in resolving disputes amicably and efficiently, and most participant concerns can be resolved quickly and to the participant's satisfaction by emailing GoFundMe Charity platform's support team at Maximus@gofundme.com. If such efforts prove unsuccessful, a party who intends to seek arbitration must first send to the other, by certified mail, a written Notice of Dispute ("Notice"). The Notice to the Sponsor should be sent to All Within My Hands Foundation, 454 Las Gallinas Ave. #123, San Rafael, CA 94903 ("Notice Address"). The Notice must (i) describe the nature and basis of the claim or dispute and (ii) set forth the specific relief sought. If Sponsor or the GFM Charity Platform, as applicable, and you do not resolve the claim within sixty (60) calendar days after the Notice is received, you, Sponsor or the GFM Charity Platform may commence an arbitration proceeding. During the arbitration, the amount of any settlement offer made by Sponsor, the GFM Charity Platform or you shall not be disclosed to the arbitrator until after the arbitrator determines the amount, if any, to which you, Sponsor, or the GFM Charity Platform is entitled.

(d) Arbitration Procedures: Arbitration will be conducted by a neutral arbitrator in accordance with the American Arbitration Association's ("AAA") rules and procedures, including the AAA's Supplementary Procedures for Consumer-Related Disputes (collectively, the "AAA Rules"), as modified by this Arbitration Agreement. For information on the AAA, please visit its website, <http://www.adr.org>. Information about the AAA Rules and fees for consumer disputes can be found at the AAA's consumer arbitration page, http://www.adr.org/consumer_arbitration. If there is any inconsistency between any term of the AAA Rules and any term of this Arbitration Agreement, the applicable terms of this Arbitration Agreement will control unless the arbitrator determines that the application of the inconsistent Arbitration Agreement terms would not result in a fundamentally fair arbitration. The arbitrator must also follow the provisions of these Official Rules as a court would. All issues are for the arbitrator to decide, including, but not limited to, issues relating to the scope, enforceability, and arbitrability of this Arbitration Agreement. Although arbitration proceedings are usually simpler and more streamlined than trials and other judicial proceedings, the arbitrator can award the same damages and relief on an individual basis that a court can award to an individual under these Official Rules and applicable law. Decisions by the arbitrator are enforceable in a court and may be overturned by a court only for very limited reasons.
